The Department of Science and Technology – Philippine Council for Health Research and Development (DOST-PCHRD), through the General Appropriations Act 2022 (GAA 2022) and through the Various Project Funds intends to apply the sum of Three Million Seven Hundred Thousand Pesos (PhP 3,700,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for each lot:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The **DOST-PCHRD** now invites bids for the above Procurement Project. Delivery of the Goods is required by not later than Thirty (30) calendar days upon receipt of the Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from **DOST-PCHRD** and inspect the Bidding Documents at the address given below during **08:00 AM to 04:00 PM**.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on July 11, 2022 to August 01, 2022 from 08:00 AM to 04:00 PM except Saturdays, Sundays and Holidays, and until 09:30AM on August 01, 2022 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

- 6. The **DOST-PCHRD** will hold a Pre-Bid Conference on **August 01, 2022 (Monday)** at **10:30AM** through video conferencing or webcasting **via Zoom Cloud Meetings**, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below and online or electronic submission to the email address as indicated below, on or before **August 01, 2022 (Monday) 10:00AM**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on **August 01, 2022 (Monday) 10:30AM.** Opening of bids is through video conferencing or webcasting **via Zoom Cloud Meetings**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The **Department of Science and Technology Philippine Council for Health Research and Development (DOST-PCHRD)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
