#### TERMS OF REFERENCE

# I. TITLE

Engagement of Services of a Certifying Body for the ISO 9001:2015 Re-Certification of the Philippine Council for Health Research and Development (PCHRD) Quality Management System (QMS)

# II. ESTIMATED BUDGET FOR THE CONTRACT

Two Hundred Ten Thousand Pesos Only (PhP 210,000.00), VAT and other taxes inclusive

### III. OBJECTIVES

The overall objective of the engagement is to provide independent confirmation that the PCHRD QMS continuously conform to the ISO 9001:2015 requirements, and if found compliant, issue the Re-Certification and conduct required Surveillance audits for two (2) consecutive years following the year of recertification.

# IV. DESCRIPTION

The engagement involves the supply of services of a Third-Party Certifying Body to conduct Surveillance Audits of PCHRD QMS based on ISO 9001:2015 Standard; issue Re-Certification and conduct Surveillance audits until 2024, after the issuance of Re-Certification for ISO 9001:2015.

# V. QUALIFICATIONS OF CERTIFYING BODY
